

SHORT FORM MINERAL LEASE

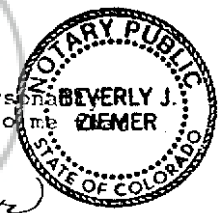

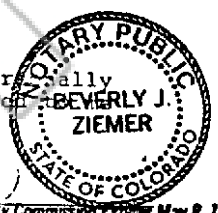

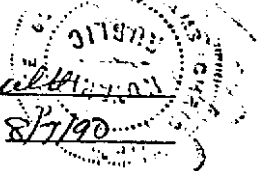
