

ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS:

That BRUCE N. BULLOCH and IRENE M. BULLOCH, his wife of Veyo, Washington County, Utah, in consideration of Ten Dollars (\$10) and other good and valuable consideration, do hereby assign to BRUCE NEILSON BULLOCH, Trustee of THE BRUCE NEILSON BULLOCH LIVING TRUST, dated 29th January 1988, all of their right, title and interest in and to a Trust Deed Note dated 30 September 1986, wherein LESTER C. MATHEWS and LORENE MATHEWS are the Makers; which Trust Deed Note is in the principal amount of Thirty-Eight Thousand Dollars and secured by a Trust Deed dated 30 September 1986, wherein LESTER C. MATHEWS and LORENE MATHEWS are Trustors, First American Title Company of Nevada is Trustee and BRUCE N. BULLOCH and IRENE M. BULLOCH, husband and wife, are Beneficiaries.
