## WILL OF MARY BARRON GRIBBLE

I, MARY BARRON GRIBBLE, of Panaca, Lincoln County, Nevada, declare this to be my will, and revoke all other wills and codicils that I may have made.

FIRST: My Executor shall pay out of my estate, without apportionment, all taxes by whatever name called payable by reason of my
death, in respect of all property included in my estate for the
purpose of computing such taxes, whether or not such property shall
pass under this will.

 EECOND: I declare that I am a widow and have had three children of my body, to-wit: Mary Lou Dietrich of Panaca, Nevada; Kaye Eleanor Pully of Las Vegas, Nevada; and Gerald Dennis Gribble of Panaca, Nevada.

THIRD: Having full faith and trust in my son, Gerald Dennis Gribble, I give all property which I own or over which I may have the power of disposition by appointment or otherwise to my son, Gerald Dennis Gribble, for his use, however, until such time as he shall have completed his education, including law school or any graduate degree or professional education that he may desire, or until his twenty-eighth (28th) birthday, whichever shall come first. During all such time, he shall first provide a home for my grandchildren, the children of May Lou Dietrich, in the home in Panaca which was purchased from the Hutchinsons. He shall have the right to dispose of any and all of the property and use the proceeds thereof to maintain the said home and the taxes and expenses thereof and

to assist himself in obtaining his education as aforesaid. On the completion of his first graduate or professional degree or attaining his twenty-eighth (28th) birthday, any and all funds or property which shall remain in his possession, I desire that he distribute in three equal shares as follows: one-third (1/3) to Gerald Dennis Gribble; one-third (1/3) to Kaye Eleanor Pully; and one-third (1/3) to the children of Mary Lou Dietrich. At this time, I desire him to have the home appraised and if the children of Mary Lou Dietrich, or their guardian or guardians in their behalf, desire to purchase the house, that they shall be allowed the opportunity to do so, allowing their one-third interest in my estate to be applied on said purchase of the house, and the balance to be applied to Gerald Dennis Gribble for distribution to himself and to Kaye Eleanor Pully.

FOURTH: I appoint my son, Gerald Dennis Gribble, Executor of my will and as substitute in such capacity, I appoint my daughter, Kaye Eleanor Pully. No fiduciary named in or appointed in connection with this will shall be required to file any bond or other security for the faithful performance of his or her duties in any jurisdiction.

FIFTH: I give my Executor full power to deal with my estate and to do all acts and exercise all rights with relation to such property, as if the absolute owner thereof. As I wish my Executor to exercise the broadest discretion in dealing with my estate, I direct that he shall not be responsible for any loss resulting from the exercise in good faith of this power.

SIXTH: If any legatee, devisee or takerunder this will shall interpose objections to its probate or in any other way contest it, such person shall forfeit his entire interest under this will and the gift, bequest or devise made to such person shall pass as part of the residue of my estate, provided, however, that if such person is a residuary taker, his or her interest shall be divded proportionately among the remaining residuary takers.

SEVENTH: If any objection shall be made to the probate of this will or any attempt shall be made to revoke the probate thereof by any of my heirs, next of kin, legatees, devisees or any beneficiary under any provision of this will, or in case any contest shall arise as to the carrying into effect of any article thereof, it is my will that any heir, next of kin, legatee, devisee or beneficiary under any provision of this will who shall make or offer or permit to be made or offered any such objection or attempt or who shall inaugurate or raise or abet any such contest shall by reason thereof forfeit any and all right or interest which he or she might otherwise have under this my will or in my estate, and shall be excluded from any share or interest in my estate as legatee, devie see, heir at law, next of kin or otherwise, and I hereby give, devise and bequeath the property, interest, articles or money constituting such devise, legacy or share in my estate which he or she or they might otherwise become entitled to such of my residuary legatees as shall not have violated this provision of my will.
