AMENDMENT TO MINING LEASE

WHEREAS, under date of December 23, 1986, a certain Mining Lease was made and entered into by and between JOSEPH P. WHEREAS, it is the desire of Lessor and Lessee in said Lease, being the undersigned, to amend said Lease,

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00) cash in hand, paid by Lessee to Lessor, and in consideration of the mutual benefits and advantages to the parties hereto, and for the further considerations provided herein, receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby amend said Mining Lease in respect to the following matters and ratify and adopt the same as amended.

Clause 3 (C) which reads in part as follows:

(C) Lessee shall pay Lessor a minimum monthly royalty regardless of actual production according to the following schedule:

Four Hundred Fifty Dollars (\$450.00) each and every month for twelve months commencing January 1, 1987.

Nine Hundred Dollars (\$900.00) each and every month for twelve months commencing January 1, 1988.

Eighteen Hundred Dollars (\$1,800.00) or 6 ounces of gold, at the option of the Lessee, or 5 ounces of gold, at the option of the Lessor, each and every month thereafter during the life of this Lease, commencing January 1, 1989.

shall be and hereby is amended to read:

(C) Lessee shall pay Lessor a minimum monthly royalty regardless of actual production according to the following schedule:

Four Hundred Fifty Dollars (\$450.00) each and every month for twenty-four months commencing January 1, 1987.

Nine Hundred Dollars (\$900.00) each and every month for twelve months commencing January 1, 1989.

Eighteen Hundred Dollars (\$1,800.00) or 6 ounces of gold, at the option of the Lessee, or 5 ounces of gold, at the option of the Lessor, each and every month thereafter during the life of this Lease, commencing January 1, 1990.
