The discovery monument is located approximately 6410 feet in a N77W direction from the common corner of sections 13 & 29 T4S, R55E & sections 18 & 30 T4S, R56E 117 RM

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location.
