# CERTIFICATE OF LOCATION

## LODE-QUARTZ

THIS IS TO CERTIFY that the HILLTOP # 3 lode mining claim

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 750 feet from the location monument in a North direction, and 750 feet in a South direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4" X 4 feet plastic feet high, inscribed "NW Corner of the Hilltop # 3 Claim;" the southwest corner is marked by a 4" X 4 feet Plastic high, inscribed "SW Corner of the HILLTOP # 3 Claim;" the southeast corner is marked by a 4" X 4 feet plastic feet high, inscribed "SE Corner of the Hilltop # 3 Claim;" the northeast corner is marked by a 4x4 four feet feet high, inscribed "NE Corner of the Hilltop # 3 Claim." There is also a Plastic 4" X 4' at the center of each side line.

The monumentation and marking of the corners was completed by the 30 day of May, 1988.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
