CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, THAT Rodney D. Scheetz, 361 Palmer Street, Delta, Colorado 81416, the undersigned, hereby locates the ROZ 704 Lode Mining Claim on the 1 day of July, 1988, situated in the Unknown Mining District, Lincoln County, Nevada, and by this certificate, and by right of discovery and location, claims 1500 feet, linear and horizontal measurement, along the vein thereof, said vein running 25 feet in a West direction from the point of discovery and 1475 feet in a East direction from the point of discovery, together with 300 feet on either side of the middle of said vein at the surface. The discovery monument on which notice of this claim is posted is located at said point of discovery.

The general course of this lode or vein is East and West.

The Claim is located in the NW $\frac{1}{4}$ and SW $\frac{1}{4}$ of Section 35 and NE $\frac{1}{4}$ and SE $\frac{1}{4}$ of Section 34, Township 7 North, Range 68 East, Mount Diablo Meridian, Lincoln County, State of Nevada. The location and description of each corner is as follows:

Beginning at Corner No. 1, the NE corner of the Claim, which is a 3" OD, 5' in length PVC pipe marked NE Corner No. 1 of the ROZ 704 claim, thence South a distance of 600 feet to Corner No. 2, the SE Corner of the Claim, which is a 3" OD 5' in length PVC pipe marked SE Corner No. 2 of the ROZ 704 claim; thence West a distance of 750 feet to Corner No. 3 the South Side Center; thence West a distance of 750 feet to Corner No. 4, the SW Corner of the Claim, which is a 3" OD, 5' in length PVC pipe marked SW Corner No. 4 of the ROZ 704 claim; thence North a distance of 600 feet to Corner No. 5, the NW Corner of the Claim, which is a 3" OD, 5' in length PVC pipe marked NW Corner No. 5 of the ROZ 704 claim; thence East a distance of 750 feet to Corner No. 6 the North Side Center; thence East a distance of 750 feet to Corner No. 1, the point of beginning.

Beginning at Corner No. 1 which is the NE Corner of the Claim, thence a distance of 3000 feet South and 9000 feet West to a permanent monument, which is located at the North 1/4 Corner, Section 4, Township 6 North, Range 68 East, Mount Diablo Meridian.
