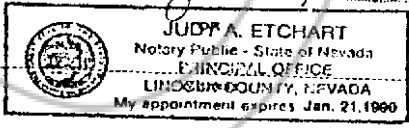

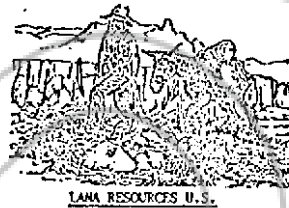

SUMMARY REPORT

UNPATENTED MINING CLAIMS TO ACCOMPANY ANNUAL ASSESSMENT WORK PROOF OF LABOR


This detailed report is filed in compliance with the requirements of Title # 30 U.S. Code, Section 28-1 for the D.E. claims Numbered # 1 thru 10 a contiguous group of Lode mining claims situated in the HorseThief mining district of Lincoln County, State of Nevada for the assessment year ending September 1, 1988.

The work consisted of Geological and Geo-chemical survey's over the entire claim group, to evaluate mineralization on the claim area, to assist in future planning further exploration and then development work. The work was done under the Geological supervision of DR. WAYNE R. BRUCE Phd. assays were done in the Lincoln Assay Company, labor and supervision by McCrosky Construction. The work was done at various times starting November, 1, and completed by August 28, 1988. The amount spent for these services was in excess of \$ 3,000.00.

The Geological survey included rock discription, examination of alteration, mapping of outcrops, beddings and faults and the interpitation of each of the above. There was a total of 100 rock samples each run for at least six elements, run through the Lincoln Assay and Chemix lab's. They were tested by Atomic Absorbtion and checked by Fire assay methods.

Results of the survey's indicate that good mineralization is present at depth with anomalous of precious base metals as well as trace elements are present and warrent further development programs as our company can afford. Drilling and trenching will be done in the near future.
