The discovery monument is located approximately 3130 feet in a S54°W direction from the common corner of sections of 25 & 36 T45 R55E & sections 30 & 31 T45 R56E MDM

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments.
