DECREE OF DIVORCE

11 The above entitled cause, coming on regularly for trial
12 before the above entitled Court this date, plaintiff appearing in
13 person and by his attorney, WILLIAM E. SWOPE, and the defendant
14 not appearing, and it appearing to the Court that service of
15 process has heretofore been made upon the defendant on the 19th
16 day of October, 1988, she having failed to answer or otherwise
17 plead to plaintiff's Complaint on file herein within the time
18 allowed by law and her default having been duly and regularly
19 entered; and the Court having jurisdiction over the person of the
20 plaintiff and having before it all of the files, pleadings and
21 papers in the action, and being fully advised in the premises,
22 and fully satisfied that the action has been duly and regularly
23 commenced, finds that each of the allegations contained in
24 plaintiff's Complaint is true and the Court deeming this a proper
25 case, therefore on motion of WILLIAM E. SWOPE, attorney for plain-
26 tiff,

27 IT IS ORDERED, ADJUDGED AND DECREED that the bonds of
28 matrimony now and heretofore existing between the plaintiff,

1 LOUIS JOHN CASEROTTI, and the defendant, BARBARA ANN CASEROTTI,
2 be and the same are, wholly dissolved and a decree of absolute
3 divorce is hereby granted to the plaintiff, and each of the
