We (or I) claim 1500 linear feet along the course of the ledge,  
lode or vein, extending 25 feet from the location monument in a  
Easterly direction and 1425 feet in a Westerly direction, together  
with 700 feet on each side of the center of the ledge for the  
entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial  
PVC pipe monuments firmly set in the ground and bearing applicable  
monument designation. The description of such claim is: Beginning at
