To tie this claim to the Public Survey, begin at the Northwest corner of Section 31, Township 8 South, Range 69 East M.D.B. & H, thence 10,571 feet Easterly to the SE corner of VIP No. 1, Thence Northerly 1800 feet to the NE corner of VIP No. 5.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1475 feet from the location monument in a Easterly direction and 25 feet in a Westerly direction, together with 200 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC pipe monuments firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:

thence, South 600 feet to the Southeast corner,  
thence, West 750 feet to the South side center,
