
OWNER'S CERTIFICATE

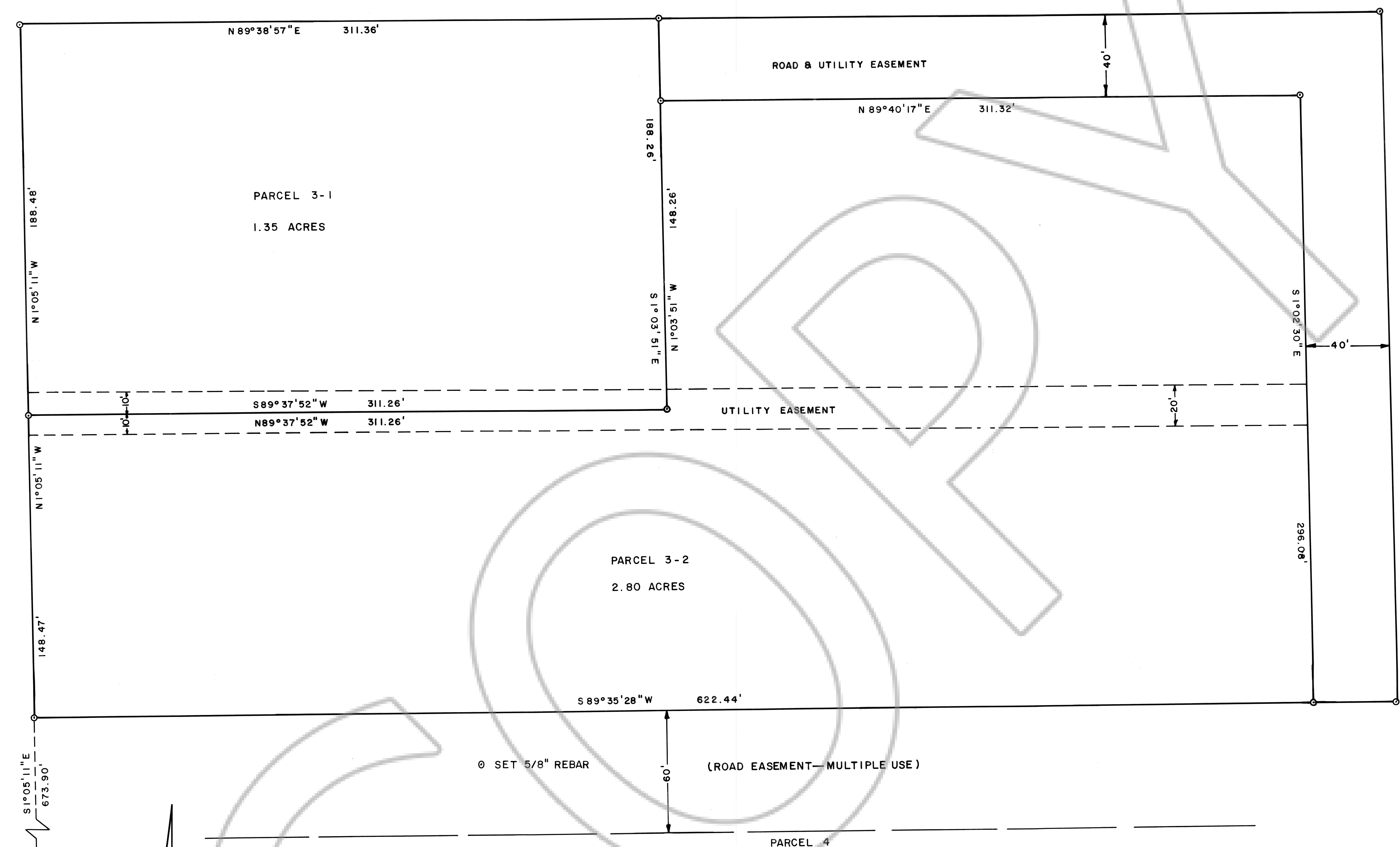

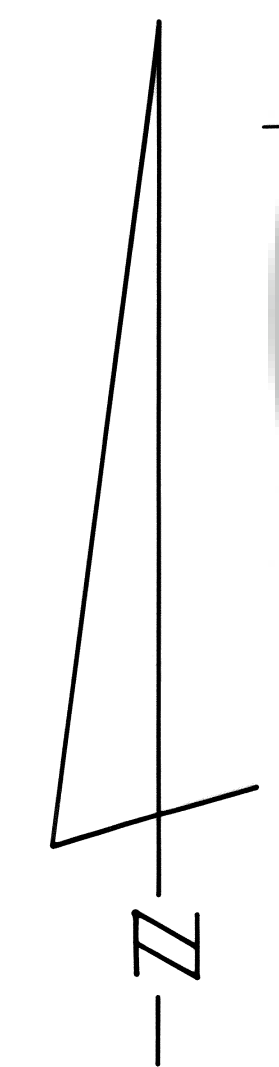

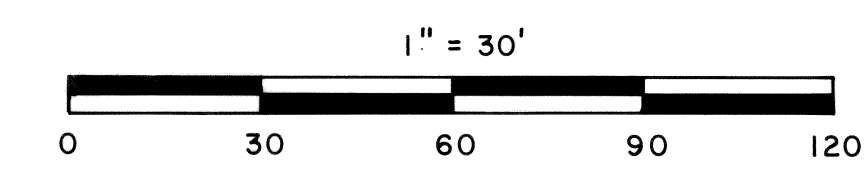
