THIS DEED OF TRUST, made this 13th day of March, 19 89,  
between Kevin D. Smith and Ann P. Smith Husband and Wife as Joint Tenants

whose mailing address is P.O. Box 101, Caliente Nevada 89008, herein called GRANTOR or TRUSTOR,

**LAND TITLE OF NEVADA INC. a NEVADA corporation, herein called Trustee, and**  
**Nevada Bank & Trust, PO box 428, Caliente NV 89008**

WITNESSETH, THAT WHEREAS Trustee has borrowed and received from Beneficiary in lawful money of the United States the sum of (40,300.00) and has agreed to repay the same, with interest, to Beneficiary in lawful money of the United States according to the terms of a promissory note of even date herewith, executed and delivered thereto by Trustee.

NOW, THEREFORE, for the purpose of securing such agreement of the Trustee herein contained, including payment of the said promissory note and of any money with interest thereon that may be advanced by or otherwise become due to Trustee or Beneficiary under the provisions hereof and for the purpose of securing payment of such additional sums as may hereafter be advanced for the account of Trustee by Beneficiary with interest thereon, TRUSTOR irrevocably GRANTS AND TRANSFERS TO TRUSTEE, in TRUST WITH POWER OF SALE, all that property in Lincoln County, Nevada, described as:

Lots numbered Twenty-Seven (27) and Twenty-Eight in the Amended Rowan Subdivision to the City of Caliente, Lincoln County, Nevada. (28)

EXCEPTING all mineral and mineral rights of every kind and character now known to exist or hereinafter discovered including without limiting the generality of the foregoing oil and gas rights thereto, together with the sole, exclusive and perpetual right to explore for, remove and dispose of said minerals by any means or methods suitable but without entering upon or using the surface of the lands hereby conveyed and in such manner as not to damage the surface of said lands or to interfere with the use thereof.


TOGETHER WITH all appurtenances in which Trustee has any interest, including water rights benefiting said realty whether represented by shares of a company or otherwise; and  
TRUSTOR ALSO ASSIGNS to Beneficiary all rents, issues and profits of said realty, reserving the right to collect and use the same except during continuance of any party hereto.

TO HAVE AND TO HOLD said property open and subject to the trusts and agreements herein set forth and incorporated herein by reference. The following covenants, Nos. 1, 2, 3, 4, 5, 6, 7, 8 and 9 of MRS 107.000 are hereby adopted and made a part of this deed of trust, EXCEPT ONLY that the amounts agreed upon by the parties to this instrument with respect to covenants Nos. 2, 3, 4, 5, 6, 7 incorporated by reference of such trusts and agreements is respectively as follows: Covenant No. 2, \$52,200.00; Covenant No. 4, Variable; 20; Covenant No. 7, 20. Such provisions so incorporated shall have the same force and effect as though specifically set forth and incorporated verbatim in this deed of trust.


