

GRANT, BARGAIN, SALE DEED

THIS INDENTURE, made this 11th day of April, A.D. 1989, between Dominick Belingheri and Ruth Belingheri, husband and wife the parties of the first part and Idamae Thome, a single woman, the party of the second part,

WITNESSETH: That the said parties of the first part in consideration of the sum of Ten Dollars, lawful money of the united States of America, and other and further valuable consideration, the receipt whereof is hereby acknowledged do by these presents, GRANT, BARGAIN and SELL unto the said party of the second part, and to her heirs, successors and assigns forever, all that certain parcel of land situate in the town of Pioche, County of Lincoln, State of Nevada, bounded and described as follows, to-wit:

The West 20 feet of the East half of lot numbered 14 in block numbered Thirteen (13) of the Pioche Mines Consolidated, Inc. Addition, Supplement "B" to the official map of the town of Pioche, Nevada, and further described as follows:

Beginning at a point 5 feet West of the Northeast corner of said lot 14, said point being on the south line of Comstock Street, thence running west along the south side of Comstock Street, a distance of 20 feet; thence running at right angles South a distance of 90 feet to the South line of said lot 14; thence running East on the south line of said lot 14 a distance of 20 feet; thence running at right angles North a distance of 90 feet to the place of beginning.

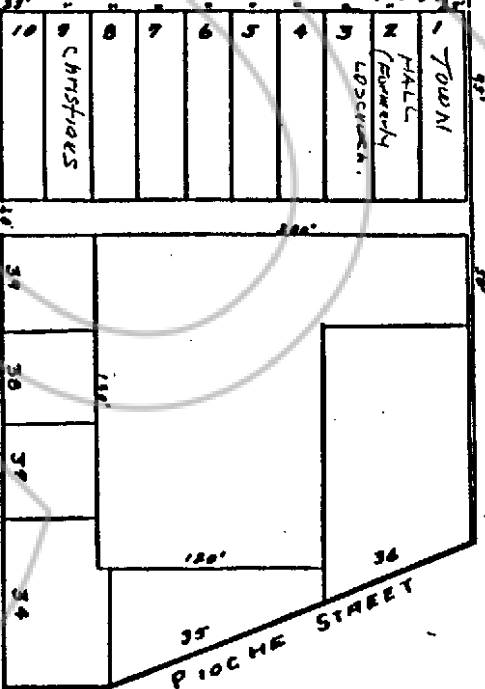
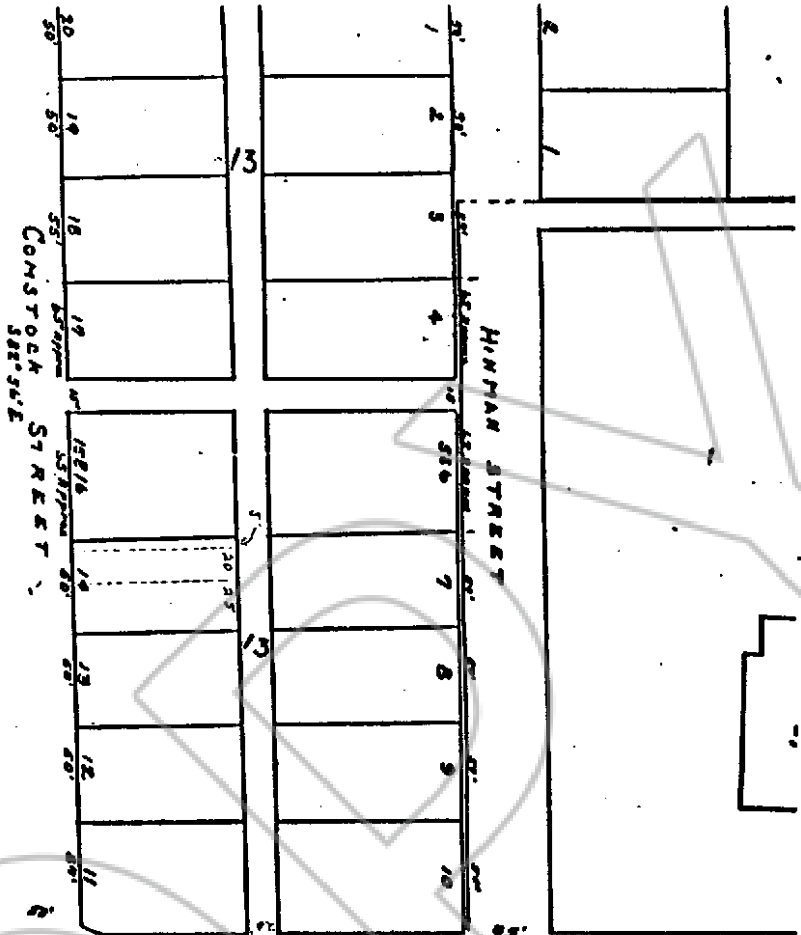
