

ADDENDUM TO AGREEMENT

THIS ADDENDUM to AGREEMENT made this 3rd day of May, 1989,
by and between MARGARET (CATAPANO) SANTIAGO and QUADRANGLE
RESOURCES, INC.

WITNESSETH:

WHEREAS, MARGARET (CATAPANO) SANTIAGO and QUADRANGLE
RESOURCES, INC. have executed an Agreement on May 1, 1989, for
the sale of certain mineral tailings, located in Ponds Land 1
and 2 in the west side of the South Mill Tailings Ponds, also
known as the Castleton Tailings Ponds, located in Pioche,
Nevada, and

WHEREAS, the parties desire to add an Addendum to that
contract as hereinafter provided.

NOW, THEREFORE, for and in consideration of the mutual
promises of the parties hereto, hereinafter contained, it is
agreed as follows:

1. The parties agree that, in the event a dispute arises
between MARGARET (CATAPANO) SANTIAGO and JOHN SANTIAGO, in
connection with the aforementioned Tailings Ponds 1 and 2, which
prevent QUADRANGLE RESOURCES, INC. from removing any of the
tailings from those ponds, any payments in connection with the
removal of tailings from those ponds, pursuant to the May 1,
1989 Agreement, shall be deferred to a future time permitting the
removal of said tailings.

2. The parties agree, for the purpose of this Agreement,
that a prevention under the terms hereof shall mean by a Court
Order or any law enforcement agency.

3. The parties further agree that, in the event any

prevention as aforesated occurs, they will cooperate with each other in removing any obstacles preventing the removal of the tailings aforesated.

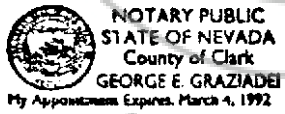
