**LODE MINING CLAIM  
CERTIFICATE OF LOCATION**

NOTICE IS HEREBY GIVEN that PATHFINDER GOLD CORPORATION, whose address is 935 North 1300 West, Suite 5, St. George, Utah 84770; hereby claims the land hereinafter described as a Lode Mining Claim under and pursuant to the laws of the United States of America and of the State of Nevada, and in making such claim and for the purpose of establishing its rights thereto, hereby certifies:
