**LODE MINING CLAIM  
CERTIFICATE OF LOCATION**

NOTICE IS HEREBY GIVEN that PATHFINDER GOLD CORPORATION, whose address is 935 North 1300 West, Suite 6, St. George, Utah 84770; hereby claims the land hereinafter described as a Lode Mining Claim under and pursuant to the laws of the United States of America and of the State of Nevada, and in making such claim and for the purpose of establishing its rights thereto, hereby certifies:

THAT A LOBE, ledge, vein or deposit of valuable minerals, consisting of gold and other valuable minerals within the limits of this claim as hereinafter established was discovered on the 8th day of March, 1989.

THAT THE NAME of this claim is VI US.

EXTENT: From the discovery monument, this claim extends in length 50 feet in a N 17° E direction and 1750 feet in a S 17° W direction, said line being the general course of the claim; and includes in width 300 feet on each side of this centerline.
