

TREASURER'S RECONVEYANCE DEED

WHEREAS, the real property hereinafter described was assessed to Marcus Avilez, Crystal Springs Ranch, Hiko, NV, and a tax was levied on said property for the fiscal years 1986-1987, 1987-1988, 1988-1989 and

WHEREAS, the taxes for the aforesaid years were not paid within the time allowed by law and said property was conveyed by Tax Deed on May 5, 1989, from Ruby Lister, County Treasurer and Ex-officio Tax Receiver of Lincoln County, Nevada, to Ruby Lister, County Treasurer of Lincoln County, Nevada, as Trustee in Trust for the use and benefit of the State of Nevada and the County of Lincoln, said conveyance being made after compliance with Nevada Law was had, and

WHEREAS, Nevada Revised Statutes 361.585 (3) provides as follows: "Notwithstanding the provisions of NRS 361.595 or 361.603, at any time during the 90 day period specified in NRS 361.603, or prior to the Public Notice of Sale by a County Treasurer, pursuant to NRS 361.595, of any property held in trust by him by virtue of any deed made pursuant to the provisions of this chapter, any person or persons specified in subsection 4 is entitled to have such property reconveyed upon payment to the County Treasurer of an amount equal to the taxes accrued, together with any costs, penalties and interest legally chargeable against such property. A reconveyance shall not be made after expiration of the 90 day period specified in NRS 361.603 or after commencement of posting or publication of public notice pursuant to NRS 361.595", and

WHEREAS, the said Marcus Avilez of Crystal Springs Ranch, Hiko, NV 89017, the Grantee herein, has tendered to the County Treasurer the proper amount of money as is required in such cases and no public notice of sale having been given by the County Treasurer.

NOW, THEREFORE, THIS INDENTURE made this 5th day of June A.D., 1989, between Ruby Lister, County Treasurer of Lincoln County, Nevada, as Trustee, for the use and benefit of the State of Nevada, and the County of Lincoln, as Grantor, and Marcus Avilez as Grantee:

WITNESSETH: That the Grantor, in consideration of EIGHTY EIGHT DOLLARS AND SEVEN CENTS (\$88.07) plus recording costs, receipt whereof is hereby acknowledged, does by these presents release and forever QUITCLAIM unto the said Grantee, Marcus Avilez, his heirs and assigns forever, all the right, title and interest of said Grantor in and to the following described property situated in the County of Lincoln, State of Nevada, and bounded and described as follows:

Assessor's Parcel Number 04-114-04; The certain parcel described as: Beginning at the northwest (NW) corner of the property belonging to Press Lamb on the 23rd day of July, 1955, and running thence west 495 feet to a point; thence south 217 feet to the TRUE POINT OF BEGINNING; thence continuing south 110 feet to a point; thence east 95 feet to the cement irrigation ditch; thence northeasterly along said irrigation ditch 110 feet to a point; thence west 122 feet to the TRUE POINT OF BEGINNING, being situate in the Northeast Quarter of the Northwest Quarter (NE1/4NW1/4), Section 8, Township 7 South, Range 61 East, M.D.B.&M. in Pahrnagat Valley, Lincoln County, Nevada, corrals and pens.

TOGETHER WITH THE TENEMENTS, hereditaments and appurtenances thereto belonging or appertaining and the reversions, remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD the said premises, together with the appurtenances, unto said Grantee and to their heirs and assigns forever.
