

DECLARATION OF HOMESTEAD

KNOWN ALL MEN BY THESE PRESENTS:

That the undersigned, to-wit: DARLENE CAYTON does hereby certify and declare as follows:

1. That DARLENE CAYTON is the head of the household.
2. That she is now residing on the land and premises located in the City of Caliente, County of Lincoln, State of Nevada, more particularly as follows:

A portion of the W $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 8, T4S., R67E., MDB&M described as follows:

Beginning at a point from which the Southwest corner of said section 8, bears S. 24°38'35" W. a distance of 1506.13 feet, and located 165.00 feet from the centerline of Rowan Drive in the City of Caliente, Nevada; thence running N. 59°57'E. (parallel to said Rowan Drive), 207.64 feet; thence S. 30°03'E., 75.00 feet; thence S. 05°12'27" W., 245.76 Feet; thence N. 43°40' W. 283.50 feet to the point of beginning and containing an area of 0.820 acres, more or less.

3. That they claim the land and premises hereinabove described together with the dwelling house thereon and its appurtenances, as a Homestead.
4. That they estimate the actual cash value of the land and premises hereinabove described to be \$17,500.⁰⁰.
5. No former Declaration of Homestead in the State of Nevada has been made by her.
6. That the character of said property so sought to be homesteaded and the improvements, which have been

affixed thereto consist of land and a dwelling house contained thereon.

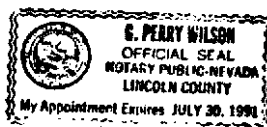
