each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4x4 P.V.C. Pipe 4 feet high, inscribed "NW Corner  
of the Dodge Spring No 1 Claim;" the southwest corner is marked by a 4x4 P.V.C. Pipe 4 feet  
high, inscribed "SW Corner of the Dodge Spring No 1 Claim;" the southeast corner is marked by  
a 4x4 P.V.C. Pipe 4 feet high, inscribed "SE Corner of the Dodge Spring No 1 Claim;" the  
northeast corner is marked by a 4x4 P.V.C. Pipe 4 feet high, inscribed "NE Corner of the  
Dodge Spring No 1 Claim." There is also a \_\_\_\_\_ at the center of each side line.

The monumentation and marking of the corners was completed by the 10 day of Oct, 1989.  
(must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim  
filing fee has been paid to the County Recorder.
