I, EUGENE HOWARD COLLINS, also known as GENE COLLINS, being of sound mind, voluntarily make known my desire that my dying shall not be artificially prolonged under the following circumstances.

A. If at any time I am in a terminal condition and become comatose or may otherwise be rendered incapable of communicating with my attending physician, and my death is imminent because of an incurable disease, illness or injury, I direct that life-sustaining procedures be withheld and withdrawn, and that I be permitted to die naturally.

B. It is my intention that this directive be honored by my family and attending physician as the final expression of my legal right to refuse medical or surgical treatment and to accept the consequences of my refusal.
