14 The verified Petition of DAVID B. CORLEY coming on
15 regularly for hearing pursuant to Notice given as by statute
16 required; proof of the giving of Notice of said Petition having
17 been made, and it appearing to the satisfaction of the Court that
18 said Notice has been regularly given, and the Court so finding;
19 the Court having considered said Petition and taken evidence in
20 support thereof, and the Court having found the value of the
21 hereinafter described property does not exceed the gross sum of
22 Twenty Five Thousand Dollars (\$25,000.00); and that DAVID B.

24 ROSE GARRA, and LORRAINE WIMER are the surviving heirs of the
