TRUST DEED

This trust deed is made this the 1st day of February 1990, between

as BENEFICIARY'S, whose address is 58674 p.o. Box 172 Picoche Nevada 89043,
TRUSTEE HEREBY CONVEYS AND WARRANTS TO TRUSTEE IN TRUST, WITH POWER OF
SALE, the following property situated in Lincoln County Nevada, the Unincorpor-
ated town of URSINE (EAGLE VALLEY), Township 2 North, Range 69 East, N.D.S. & N
Section #35, lying within the S.W. 1/4 of Section # 35, being parcel # 6 of

TOGETHER with all buildings (LOG HOME), fixtures and improvements thereon
and all rights of way easements, rents, issues, profits, income, tenements,

forth.


