

**CERTIFICATE OF LOCATION - NEVADA**

THE UNDERSIGNED, hereby certifies that AMERICAN COPPER & NICKEL COMPANY, INC., by its Agent, the undersigned, does hereby locate the LS 1 Lode Mining Claim on this 6th day of March, 1990, situated in the Unknown Mining District, Lincoln County, Nevada.

Said Claim is located in the NE(NW)(SE)(SW) (Quarter) Section(s) 11(11)(2)(2), Township 6 North, Range 69 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, <u>600</u> feet in a <u>S 45° E</u> direction to Post No.2, marked - <u>LS 1</u> - <u>2</u>
Thence, <u>750</u> feet in a <u>S 45° W</u> direction to Post No.3, marked - <u>LS 1</u> - <u>3</u>
Thence, <u>750</u> feet in a <u>S 45° W</u> direction to Post No.4, marked - <u>LS 1</u> - <u>4</u>
Thence, <u>600</u> feet in a <u>N 45° W</u> direction to Post No.5, marked - <u>LS 1</u> - <u>5</u>
Thence, <u>750</u> feet in a <u>N 45° E</u> direction to Post No.6, marked - <u>LS 1</u> - <u>6</u>
Thence, <u>750</u> feet in a <u>N 45° E</u> direction to Post No.1, marked - <u>LS 1</u> - <u>1</u>

the point of beginning and all posts being 3" dia. X 4' long durable plastic pipe.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 750 feet in a N 45° E direction and 750 feet in a S 45° W direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N 45° E and S 45° W.

To tie this Claim to the Public Survey, begin at the Northeast corner, Section 2, Township 6 N., Range 69 E., Mt. Diablo P.M., and bear S 45° W, 5400 feet and S 45° E, 1490 feet to the northeast corner of this Claim.

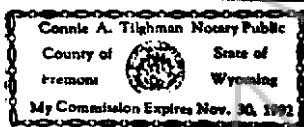
