CERTIFICATE OF LOCATION

The undersigned certifies as follows:

- The name and address of the locator is:
Cominco American Resources Incorporated

- On the 27th day of April, 1990, pursuant to and in compliance with the mining laws of the United States and the State of Nevada, the undersigned located and claimed the lode mining claim called the GARBO #76 Lode Mining Claim (the "Claim").
- The Claim is located in Lincoln County, Nevada, in the Ely Mining District approximately within the following quarter sections, Section, Township, and Range, Mount Diablo Meridian:
SW ¼ of Section 30, Township 1 North, Range 68 East
SE ¼ of Section 30, Township 1 North, Range 68 East
- The general course of the lode or vein, as near as may be determined is north and south.
- The locator claims 25 feet in a south direction and 1475 feet in a north direction from the monument of location at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the vein or lode.
- The monument of location is approximately 10,628 feet in a S 14°48'E direction from a readily identifiable landmark, being the NE corner of Section 24, Township 1 North, Range 67 East, Mount Diablo Baseline and Meridian.
- The position of each corner of the Claim is shown on the mining claim map recorded herewith. The number, position and markings on each corner or side line center monument are as follows:

- As erected on the ground, the monument of location and each corner and side line center monument consist of a PVC pipe, 3 inches in diameter by 5 feet long, set one foot in the ground and marked as described above with 3" by 5" aluminum tags.
- The monumentation and marking of the monument on the ground were completed within sixty (60) days from the date of posting of the Notice of Location. The location work consisted of making and recording of duplicate claim maps filed herewith and incorporated hereby by reference.
