ORDER SETTLING FIRST AND FINAL ACCOUNT OF
ADMINISTRATRIX; DECREE OF DISTRIBUTION AND
APPROVAL OF ATTORNEY'S FEES

SHARON JACOBY, Administratrix of the Estate of DOUGLAS M. HESTBECK, Deceased, having rendered and filed here on the 28th day of January, 1988, a First and Final Account and report of her administration of said Estate and Petition for Final Distribution and Application for Attorney's Fees, and said account and petition having come on regularly to be heard this day, KEVIN M. KELLY, ESQ., appearing as Attorney for Petitioner, the Court, after examining the said account and petition and hearing the evidence, FINDS:

1. That due and proper notice of this hearing has been given in the manner prescribed by law.
2. That said first and final account is in all respects true and correct.
3. That due and legal notice to the creditors of said estate has been given in the manner and for the time required by law, and that the time for filing creditor's claims has expired. That one creditor's claims was filed against this Estate, and that has been paid and receipts were heretofore filed.

3 5. That the assets of the Estate consist of the following:

- 4 A. Residence located at 2505 Flower Ave., N. Las Vegas, Nevada, \$43,000.00
- 5 B. Undeveloped real property located in Caliente, Nevada \$10,000.00
- 6 C. Valley Bank of Nevada account \$36,946.32

8 6. That there were no federal or state taxes attributed to
9 this Estate.

10 7. That KEVIN M. KELLY, ESQ., has rendered extensive legal
11 services in the probate of said Estate and that a fair and
12 reasonable sum, as agreed by the Administratrix is 5% of the
13 Estate, and is entitled to compensation in the amount of
14 \$4,497.31.

15 8. That the Administratrix has rendered extensive
16 managorial and administrative services to the Estate and pursuant
17 to NRS 150.020 is entitled to compensation in the amount of
18 \$2,848.38.

19 10. That the Estate be distributed as follows:

20 A. That all of the children of the Decedent, SHARON
21 JACOBY, MARIE REEDER, CHRISTINA HESTBECK and DOUGLAS HESTBECK,
22 JR., be placed on the Deeds of the property located at 2505 Flower

3 IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED as follows:
4 1. That said account and report is approved, allowed and
5 settled.

6 2. That the Administratrix is authorized to make payment
7 to KEVIN M. KELLY, ESQ., in the sum of \$4,497.31 from the assets
8 of the Estate, as and for attorney's fees and costs incurred
9 herein.

10 3. That the Administratrix is authorized to make payment
11 to herself in the sum of \$2,848.38 from the assets of the Estate,
12 as and for administrative fees and costs incurred herein.

13 5. That the Administratrix is authorized to distribute the
14 remainder of the Estate as set forth above.

15 6. That the Administratrix is hereby authorized and
16 directed to execute any and all instruments necessary to
17 effectuate distribution.

18 7. That the administration of the above-entitled Estate be
19 brought to a close, and upon filing herein and proper receipts,
20 said Administratrix be discharged.
