hearing has been given as required by law and by the order of the
Court; and said petition being now presented to the court, and no
person appearing to contest or object to the same, the court, after
hearing the evidence, being satisfied that all taxes upon the
property of the estate have been fully paid, orders distribution of
said estate as follows:

It is ordered, adjudged, and decreed by the court, that
said deceased died intestate, and left surviving, as his only heir
at law, that certain person whose name and relationship to said
deceased is as follows, to wit:

And that the residue of the estate of said deceased, as
hereinafter described, and all other property of said estate
whether described herein or not, be distributed according to law,
as follows, to wit: To Emma Conaway mother of said deceased all

money of the United States in the sum of \$4,882.50.
