

LODE MINING CLAIM
CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that PATHFINDER EXPLORATION CORPORATION, whose address is 255 Glendale Avenue, Suite 26, Sparks, Nevada 89431; hereby claims the land hereinafter described as a Lode Mining Claim under and pursuant to the laws of the United States of America and of the State of Nevada, and in making such claim and for the purpose of establishing its rights thereto, hereby certifies:

THAT A LODE, ledge, vein or deposit of valuable minerals, consisting of gold and other valuable minerals within the limits of this claim as hereinafter established was discovered on the 20th day of June, 1990.
