

**LODE MINING CLAIM
CERTIFICATE OF LOCATION**

NOTICE IS HEREBY GIVEN that PATHFINDER EXPLORATION CORPORATION, whose address is 255 Glendale Avenue, Suite 26, Sparks, Nevada 89431; hereby claims the land hereinafter described as a Lode Mining Claim under and pursuant to the laws of the United States of America and of the State of Nevada, and in making such claim and for the purpose of establishing its rights thereto, hereby certifies:
