heirs, successors and assigns and assigns forever.

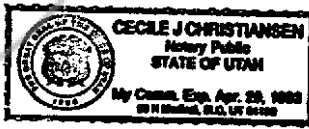

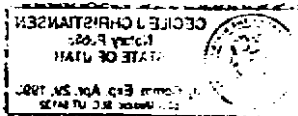
