CERTIFICATE OF LOCATION

To tie this claim to the Public Survey, begin at the Northwest corner of Section 30, Township 3 South, Range 58 East, Mount Diablo Base and Meridian, thence 1500 feet South and 800 feet West to the Northeast corner of this claim.

The general course of the lode or vein is North to South.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 10 feet from the location monument in a Northerly direction and 1490 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC pipe Monuments, firmly set in the ground and bearing applicable monument designation. The description of this claim is: Beginning at the Northeast Corner
