CERTIFICATE OF LOCATION

LODE CLAIM

HIS IS TO CERTIFY that the ECON 1004 lode mining claim was located on the 24th day of August, 1990.

To tie this claim to the Public Survey, begin at the Northwest corner of Section 30, Township South, Range 58 East, Mount Diablo Base and Meridian, thence 6400 feet South and 12,700 feet East to the Northeast corner of this claim.

The general course of the lode or vein is North to South.

The (or 1) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1490 feet from the location monument in a Northerly direction and 10 feet in a Westerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.
