CERTIFICATE OF LOCATION

LODE CLAIM

To tie this claim to the Public Survey, begin at the Northwest corner of Section 30, Township _____ South, Range 58 East, Mount Diablo Base and Meridian, thence 13,900 feet South and 1700 feet West to the Northeast corner of this claim.

The general course of the lode or vein is North to South.

The (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1490 feet from the location monument in a Northerly direction and 10 feet in a southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC pipe monuments, firmly set in the ground and bearing applicable monument designation. The description of this claim is: Beginning at the Northeast Corner:

hence, South 750 feet to the East Side Center, a 3" in diameter by 5' in length PVC pipe,

hence, North 750 feet to the West Side Center, a 3" in diameter by 5' in length PVC pipe,
hence, North 750 feet to the Northwest Corner, a 3" in diameter by 5' in length PVC pipe,
hence, East 600 feet to the Northeast Corner, a 3" in diameter by 5' in length PVC pipe,
his point and place of beginning.

The monumentation and marking of the exterior boundaries of this claim was completed by the 5th day of August, 1990.
