WHO ARE CITIZENS OF THE UNITED STATES BY BIRTH, DID LOCATE ON THIS 9TH DAY OF MAY, 1990, THE BONNIE #4 LODE MINING CLAIM UNDER AND PURSUANT TO THE MINING LAWS OF THE UNITED STATES AND THE STATE OF NEVADA.
