OF THE UNITED STATES AND THE STATE OF NEVADA. SAID CLAIM IS LOCATED UPON A

A DISTANCE OF 600 FEET TO THE SE CORNER NO. 4, THENCE DUE WEST,
A DISTANCE OF 1500 FEET TO THE SW CORNER NO. 6, THENCE DUE NORTH,
