1 Judgment and that Plaintiff is entitled to the relief prayed
2 for in her Complaint and good cause appearing therefore,

3 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the bonds
4 of matrimony now and heretofore existing between the Plaintiff
5 and Defendant be, and the same are hereby wholly dissolved, set
6 aside and forever held for naught, and an absolute Decree of
7 Divorce is hereby granted to Plaintiff and the parties hereto,
8 and each of them, are hereby restored to the status of a
9 single, unmarried person; and it is

10 FURTHER ORDERED that the Plaintiff and Defendant will be
11 awarded joint legal custody with the Plaintiff having physical
12 custody of the minor child to-wit: NATHANIEL REEVE, born
13 September, 5, 1979. The Defendant shall have reasonable
14 rights of visitation; and it is
