THEREFORE, the undersigned hereby substitutes SECURITY PACIFIC BANK NEVADA as Trustee under said Deed of Trust.

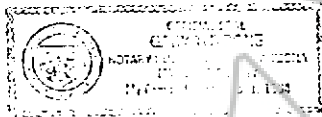
