The above claims are being held by the Owner for the valuable minerals contained in or on said claims and the Owner intends to continue diligent exploration and development of said claims.

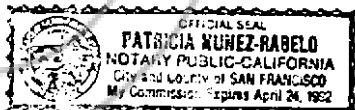
An Affidavit of Assessment Work was not filed for the current year because that requirement does not commence until September 1, 1990, and must be completed by September 1, 1991.
