## POWER OF ATTORNEY

I, Ronald W. Such powers of execution shall include, without limiting in any way the generality of the foregoing, the power (1) to execute, acknowledge, swear to, deliver and file offers to lease oil and gas interests and leases of oil and gas interests for the sole and exclusive benefit of TGWC and not on behalf of any other person in whole or in part and (2) to execute and deliver all contracts, purchase and sale agreements, conveyances, leases, assignments of leases, farmouts, farm-ins, rights-of-way, operating agreements, unit agreements, surface damage agreements, division orders, licensing agreements and all other instruments of any kind or nature relating to the oil and gas interests, including any agreements with or instruments required by any governmental agency.

TGWC agrees to be bound by any such executions and walves any and all defenses which may be available to TGWC to contest, negate or disaffirm the actions of said attorney-in-fact under this power of attorney.

TGWC may revoke the power of attorney created in this instrument by a written instrument delivered to the attorney-in-fact and filed in all of the various land offices of the Bureau of Land Management, state land office and county records in which this instrument has been filed.

Unless sooner revoked as provided above, this power of attorney shall automatically expire upon the occurrence of the earlier of: (a) the death of Samuel Gary, Jr., or (b) a determination by a court of competent jurisdiction that Samuel Gary, Jr. is incapacitated.

This power of attorney is executed and delivered in the State of Colorado, and the laws of the State of Colorado shall govern all questions as to the validity of this power and as to the construction of its provisions.
