The claim is 1500 feet long and 600 feet wide, and 10 feet is claimed in a N65°E direction and 1490 feet in a S65°W direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the N65°E to the S65°W.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by Aluminum tag with graphic description.

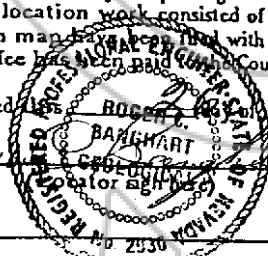
The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

Corner No. 6 is a 4" x 4" wooden post

The monumentation and marking of the corners was completed by the 26 day of March, 1991.

The location map has been filed with the Lincoln County Recorder, and the \$15.00 lode-claim filing fee has been paid to County Recorder.
