The general course of the lode deposit and premises is from the S65°W to the N65°E.

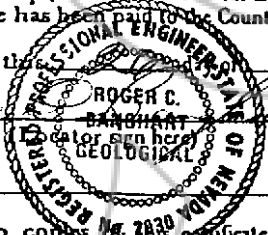
