NYLAINE BELCHER having been ordered to appear before the Court on the 8th day of March, 1991, at the hour of 10:00 o'clock a.m., to show cause why she should not be held in contempt for having disobeyed the Order of the Court filed November 15, 1990, and the Motion of BARBARA SHERMAN for supplement relief having also come before the Court at the same time and date, the Petitioner, BARBARA SHERMAN, appearing by and through her Attorney, RICHARD KOCH, ESQ., and NYLAINE BELCHER not appearing but being represented by her Attorney, GARY D. FAIRMAN, ESQ., and the Court having examined the said Motion and supporting Affidavit, and having heard the representations and arguments of counsel, and good cause appearing, therefor;

1 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the
2 Executrix of the above-entitled Estate, NYLAINE BELCHER, is in
3 contempt of this Court's Order filed on November 15, 1990, in that
4 she has willfully failed to convey common stock having a bid price
5 of Fifty Thousand Dollars (\$50,000.00) to BARBARA SHERMAN on or
6 before the date of distribution of the assets of the Estate.

7 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
8 hearing on this matter shall be continued to April 22, 1991, at the
9 hour of 10:00 o'clock a.m., and that NYLAINE BELCHER shall have
10 until that date to purge herself of contempt by conveying to BARBARA
11 SHERMAN additional case or common stock having a bid value in the
12 amount of Twenty-Six Thousand One Hundred Forty & 62/100 Dollars
13 (\$26,140.62) on the date of conveyance, said sum being the amount
14 by which NYLAINE BELCHER failed to comply with this Court's said
15 Order. To further purge herself of contempt NYLAINE BELCHER shall
16 be required to pay to BARBARA SHERMAN the sum of Three Thousand
17 Sixty & 50/100 Dollars (\$3,060.50) as and for attorney's fees, plus
18 interest upon all unpaid portions of the said Fifty Thousand Dollars
19 (\$50,000.00) at the statutory rate from December 15, 1990, being
20 the date that the assets of the Estate were distributed to NYLAINE
21 BELCHER, until the time that MRS. BELCHER complies with this Court's
22 Order.

23 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that should
24 NYLAINE BELCHER fail to purge herself of contempt as set forth
25 herein by April 22, 1991, this Court shall order the immediate sale
26 by the Sheriff of Lincoln County of the real property not yet

2 The East 110 feet of Lot #3 in Block #16,
3 Town of Panaca, Nevada, per plat thereof
4 recorded in the Lincoln County Recorder's
5 Office, Pioche, Nevada, in the Panaca Town
6 Plats.

7 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
8 proceeds of the said sale shall be paid over to BARBARA SHERMAN to
9 the extent necessary to satisfy her claim against the Estate as set
10 forth herein, including attorney's fees, interest, and costs of
11 sale, and that any excess thereon shall be paid over to NYLAINE
12 BELCHER. Should there not be sufficient funds available from the
13 sale of the said real property to satisfy the claim of BARBARA
14 SHERMAN, the Court shall enter Judgment against NYLAINE BELCHER for
15 the deficiency.

16 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
17 Estate shall make no distribution of the said real property to
18 NYLAINE BELCHER unless and until such time as the claim of BARBARA
19 SHERMAN has been satisfied in full.
