CERTIFICATE OF LOCATION  
NEVADA

KNOW ALL MEN BY THESE PRESENTS, THAT GOLD FIELDS MINING CORPORATION, whose current mailing address is 1687 Cole Boulevard, P. O. Box 4014, Golden, Colorado 80402-4014, by its Agent, the undersigned, hereby locates the DEE 2 Lode Mining Claim on the 13 day of March, 1991, situated in the Unknown Mining District, Lincoln County, Nevada, and by this Certificate, and by right of discovery and location, claim 750 feet, linear and horizontal measurement, along the vein thereof, said vein running 5 feet in a S 71°17'03" W direction from the point of discovery and 745 feet in a N 71°17'03" E direction from the point of discovery, together with 25 feet on either side of the middle of said vein at the surface. The discovery monument on which Notice of Location is posted is located at said point of discovery.

The general course of this lode or vein is S 71°17'03" W and N 71°17'03" E.

The Claim is located in the NW of Section 21,  
Township 7 North, Range 68 East, Mount Diablo Meridian,  
Lincoln County, State of Nevada, and more particularly described by metes and bounds as follows:

Beginning at Corner No. 1 which is the Northeast corner of this mining claim, thence S 0° E a distance of 47.36 feet to Corner No. 2 which is the Southeast corner of this mining claim; thence S 71°17'03" W a distance of 375 feet to the South Side Center; thence S 71°17'03" W a distance of 375 feet to Corner No. 3 which is the Southwest corner of this mining claim; thence N 0° W a distance of 47.36 feet to the Corner No. 4 which is the Northwest corner of this mining claim; thence N 71°17'03" E a distance of 375 feet to the North Side Center; thence N 71°17'03" E a distance of 375 feet to Corner No. 1, the point of beginning.

Claim boundaries are monumented by durable plastic pipe at least 3 inches in diameter by 4 feet in length set one foot in the ground, one at each corner of the claim and one at the center of each side line. Each corner contains markings sufficient to appropriately designate it as a corner of said claim.

Beginning at Corner No. 1 which is the Northeast Corner of this claim, thence N 59°36'20" E, 7223.19 feet to the following natural object or permanent monument, to wit: USLM 4843, Township 7 North, Range 68 East, Mount Diablo Meridian, State of Nevada.
