GENERAL POWER OF ATTORNEY

In connection with the conduct of my business, either of my attorneys-in-fact may recover all debts that the business may owe or which may become due to others, enter into agreements and other written instruments, employ people to further the conduct of the business, pay all taxes due from the business, and do all other acts that either of my attorneys-in-fact deems necessary to carry on the business.

- (3) Appear in Actions and Suits. To appear, answer, and defend all actions and suits that may be brought against me in my name, and in my stead, to compromise, settle or adjust them or any other claims against me in any manner that either of my attorneys-in-fact deems proper.
- (4) Sell, Transfer, or Purchase Securities. To purchase, sell, or transfer stocks and bonds of any kind in my name or that of any or either attorney-in-fact and to execute and deliver any instruments required in connection with the purchase, sale, or transfer.
- (5) Manage Real Estate. To take possession of any real estate that belongs to me or to which I may be entitled to possession and to receive any rents or profits that may be due from the real estate. In connection with these powers, either of my attorneys-in-fact is empowered to enter into new leases for any term, renew or extend existing leases for any term, and to sell, convey, or mortgage any real estate affected by these presents. Either of my attorneys-in-fact is also empowered to commence and prosecute for me and in my name any suits or actions for the recovery of the possession of any real estate belonging to me or to which I may be entitled and for the rents and profits due from such real estate or from any other real estate which is the subject of these presents.
