The general course of the lode deposit and premises is from the NORTH EAST to the SOUTH WEST.

Corner No. 6 is a Plastic Post N CORNER BROWN TOP NO. 1 STAMPED

The monumentation and marking of the corners was completed by the 8 day of OCT, 1991.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
