the location being described and marked on the ground as follows, to-wit:

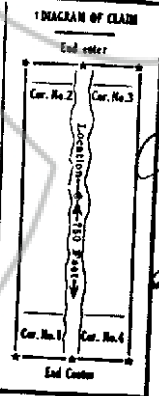

**NOTE**  
→ **DIAGRAM OF CLAIM**—The location (discovery point) and corner monuments should be delineated on the accompanying diagram to make the record of claim more perfect.
