WHO ARE CITIZENS OF THE UNITED STATES BY BIRTH, DID LOCATE ON THIS 1ST DAY OF
NOVEMBER 1991, THE WHITE HILLS LODE MINING CLAIM UNDER AND PURSUANT TO THE
MINING LAWS OF THE UNITED STATES AND THE STATE OF NEVADA. SAID CLAIM IS LOCATED
UPON A VALUABLE MINERAL DEPOSIT CONTAINING LIGHT WEIGHT MATERIALS AND OTHER
LOCATABLE MINERALS IN A VEIN, LODE, OR LEDGE SITUATED IN LINCOLN COUNTY, IN THE

THE LOCATION OF EACH CORNER MONUMENT IS GIVEN AS FOLLOWS, TO WIT:
BEGINNING AT THE SW CORNER NO. 1 OF THIS CLAIM, THENCE DUE NORTH,
A DISTANCE OF 1500 FEET TO THE NW CORNER NO. 3, THENCE DUE EAST,
A DISTANCE OF 600 FEET TO THE NE CORNER NO. 4, THENCE DUE SOUTH,
A DISTANCE OF 1500 FEET TO THE SE CORNER NO. 6, THENCE DUE WEST,
A DISTANCE OF 600 FEET TO THE POINT OF BEGINNING.
