WHO ARE CITIZENS OF THE UNITED STATES BY BIRTH, DID LOCATE ON THIS 1ST DAY OF
NOVEMBER 1991, THE BRANDON #3 LOSE MINING CLAIM UNDER AND PURSUANT TO THE MINING
LAWS OF THE UNITED STATES AND THE STATE OF NEVADA. SAID CLAIM IS LOCATED UPON A
VALUABLE MINERAL DEPOSIT CONTAINING LIGHT WEIGHT MATERIALS AND OTHER LOCATABLE
MINERALS IN A VEIN, LODGE, OR LEDGE SITUATED IN LINCOLN COUNTY, IN THE SE 1/4 OF

BEGINNING AT THE SW CORNER NO. 1 OF THIS CLAIM, THENCE DUE NORTH,
A DISTANCE OF 1500 FEET TO THE NW CORNER NO. 3, THENCE DUE EAST,
A DISTANCE OF 600 FEET TO THE NE CORNER NO. 4, THENCE DUE SOUTH,
A DISTANCE OF 1500 FEET TO THE SE CORNER NO. 6, THENCE DUE WEST,
A DISTANCE OF 600 FEET TO THE POINT OF BEGINNING.
