NOVEMBER 1991, THE TRICIA #2 LODE MINING CLAIM UNDER AND PURSUANT TO THE MINING
LAWS OF THE UNITED STATES AND THE STATE OF NEVADA. SAID CLAIM IS LOCATED UPON A

A DISTANCE OF 600 FEET TO THE NE CORNER NO. 4, THENCE DUE SOUTH,
A DISTANCE OF 1500 FEET TO THE SE CORNER NO. 6, THENCE DUE WEST,
A DISTANCE OF 600 FEET TO THE POINT OF BEGINNING.
